General CP – terrestrial animals all disease

OM – for HPAI and ND

OM – for PPR and SP&GP

OM – for LSD

SOP – for notification

SOP – biosecurity when entering the farm

SOP – Epidemiological investigation (HPAI, LSD and other diseases)

SOP – Sampling (each disease)

SOP – Killing (poultry, bovine, small ruminates, pigs)

SOP – Safe disposal

SOP – Cleaning and disinfection

CP for FMD (all susceptible species)

- OM – for FMD

- SOP – for notification

- SOP – biosecurity when entering the farm

- SOP – Epidemiological examination

- SOP – Sampling

- SOP – Killing

- SOP – Safe disposal
